3. Planning:

3.1 Applications:

(i) **18/16527/FUL:** The proposed installation of a 12.5m telecommunications column mast accommodating internal antennas, two no. microwaves dishes, pole mounted satellite dish, ancillary equipment cabinets and cabling, within a landscaped and fenced compound, together with 3m wide access track at **Pentwyn Farm, Llanbedr, NP8 1SY**

RESOLVED: to support this application.

(ii) **18/16537/TPO:** GI to provide headroom to maintain lawn, G2 – to prevent trees causing damage to roof, G3 – to give clearance to the property and to provide light, G4 – tree is growing over garage and damaging small wall and G5 – trees are leaning heavily over driveway. **The White House, Llangenny NP8 1HA**
