**3. Planning Matters:**

**3.1 Applications: to resolve responses to BBNPA/Planning Inspectorate:**

- (i) **23/21971/FUL “Proposed telecommunications installation: Proposed 25.0m Francis & Lewis T3A Lattice Tower mounted on new 7.6 x 7.6 x 1.20m deep R.C. Foundation and associated ancillary works.” Partishow Hill, Llanbedr NP8 1TA. Comments requested on additional information received - in particular the revised Landscape Visual Impact Assessment dated 01.09.2023 - ref SRN1063-LVA-6708-02 by CEP environmental.**

Members were of opinion the Landscape Visual Impact Assessment (LVIA) produced only reinforced all the objections previously made and suggested a different site would have been selected had it been prepared earlier. The LVIA does not detract from the overall message that the mast will have a major adverse impact upon the landscape.

***The Chairman closed the meeting to allow a member of the public to speak, following which the meeting was re-opened.***

Following discussion it was proposed a response is submitted reinforcing the points the report makes. Cllr Bridgwater will draft a response which will be circulated for approval prior to submission.

**7. Community Assets: to consider exploring benefits of registering local amenities, ie public house/school as community assets**

Concerns were reported over communities losing local facilities such as pubs and schools and questioned whether these can be registered as community assets? It was understood in England land of community value can be registered with the principal authority for a period of up to 5 years, during which time if it comes up for sale the community has 6 months in which to raise funds, although the owner does not have to sell it to the community. The Clerk was unsure of the process in Wales. Advice regarding the process will be obtained from One Voice Wales.

**8. Place Plans: to consider contributing to/compiling a Place Plan for the locality**

**9. Rivers - Sites of Special Scientific Interest: to discuss responsibility for maintenance.**

Following discussion it was agreed to write to Natural Resources Wales to clarify whether permission needs to be sought from them or the local authority when undertaking maintenance works on rivers/sites designated as SSSIs.

Stephen Butcher explained he is investigating the cost of replacing/repairing the safety matting under the play equipment and whilst he intends doing some repairs he does not have funds available to improve the play equipment. The budget for all playgrounds under his control in Powys amounts to £15,000, which equates to £400 per playground. Considering the current economic climate he does not know when funds will be available.

Whilst Stephen is unable to apply for grant funding the community council may wish to look into this if they wish to improve the playground. The council could also ask if it is entitled to any Section 106 monies. £10,000 would go a very long way.

The majority of the play equipment was considered adequate although the climbing frame would benefit from being rubbed down and repainted and the roundabout needs cleaning. The bench would also benefit from repair.

Stephen is unable to fund labour costs, but is willing to supply painting materials (ie turps/varnish/paint/brushes) and would welcome the council's assistance in renovating the equipment.

Councillors agreed to take this back to the council for consideration.
