- It was agreed to change the date of the October meeting to the 26<sup>th</sup> October and the December meeting to the 14<sup>th</sup> December 2026.

Cllr Bridgwater has not spoken to the plumber, but will do so prior to the next meeting.

**9. Llanbedr Community Orchard/Nature Garden: to receive up-date on maintenance plans**

Cllr Morris has removed branches from the nature garden. Council confirmed its agreement to creating a beech hedge and replacing the stakes – Cllr Morris will price up the beech trees/stakes.

The Allotment Society has suggested surplus plots are planted with fruit trees - prior to doing this members suggested the plots are advertised further afield. Cllr Morris will discuss with the Allotment Society. The item will be placed on the next agenda.

**ACTION: Cllr Morris to obtain prices for beech trees/stakes and speak to the Allotment Society.**
